

## Db2 for z/OS Database Administration Essentials and Design v12

---

### Course Summary

#### Description

This course is designed to provide the student with the knowledge to effectively and efficiently design, create and maintain Db2 databases using Db2 for z/OS. The student will learn how to use Entity Relationship Modeling techniques to design and normalize a relational database. They will demonstrate how to define Db2 objects, including Databases, Storage Groups, Tablespaces, Tables, including temporal tables, Indexes, Views, Aliases, Materialized Query Tables and Clone Tables. The student will also develop skills to load, modify, backup, and recover Db2 data using Db2 utilities. This course includes features up to and including version 12 of Db2 for z/OS.

By the end of the course, students will learn:
